



Revocation of Valuation Order

I, Colm Lavery, Commissioner of Valuation, in exercise of the powers conferred on me by section 21(5) of the Valuation Act 2001, as amended, after consultation with the Minister for Housing, Local Government and Heritage and Dún Laoghaire-Rathdown County Council, hereby order as follows:
