



**Valuation Acts 2001 to 2020  
(Donegal County Council) (Amendment) Order 2021**

I, John O’Sullivan, Commissioner of Valuation, in exercise of the powers conferred on me by section 21(4) of the Valuation Act 2001 (No. 13 of 2001), as amended by section 8 of the Valuation (Amendment) Act 2015 (No. 10 of 2015), with the consent of the Minister for Housing, Local Government and Heritage, hereby order that the *Valuation Acts 2001 to 2015 (Donegal County Council) Valuation Order 2019* be amended, as follows:

1. At paragraph 3, the publication date of 15<sup>th</sup> September 2022 shall be substituted for 15<sup>th</sup> September 2021.
2. At paragraph 4, the effective date of 28<sup>th</sup> October 2022 shall be substituted for 29<sup>th</sup> October 2021.
3. This order may be cited as the *Valuation Acts 2001 to 2020 (Donegal County Council) (Amendment) Order 2021*.
